Functions and Activities

Release of Liability

I also expressly assume all risks to the child or me participating in the activities, whether such risks are known or unknown to me at this time. I further release the church and its ministers, leaders, employees, volunteers and agents from any claim that my child may have or that I may against them as a result of injury or illness incurred during the course of participation in these activities. This release of liability is also intended to cover all claims that members of the child's or my family or estate, heirs, representatives or assigns may have against the church or its ministers, leaders, employees, volunteers, or agents. I further agree to indemnify and hold harmless the church and its ministers, leaders, employees, volunteers, or agents from any and all claims arising from my participation in its activities and programs, or as a result of injury or illness of my child during such activities. Also, I grant my permission to Wesley Way UMC to use photographs of my child taken during any activities/events sponsored by Wesley Way UMC to be used in any publications, electronic form, or media (including, but not limited to Wesley Way UMC website and Facebook page.)

First Aid and Emergency Medical Treatment
